2. Minutes from 2011 AGM

3. Committee Members and Membership

The Chairman thanked Bernie for all is work and effort in the last 2 years.

4. **Treasurer's Report**

Brian explained the spreadsheet for the monies coming in and out and confirmed that this was available on the website to view at any time.
